Stairs/steps are not allowed to exceed 20cm/200mm No fabrication onsite – Space only stands need to pre-fabricated No sharp edges are allowed on any raised flooring. Edges must be ramped down and the ramps must be within the allocated space. All custom designs that are bordered by a shell scheme need to shave off 50mm of their build on each side adjacent to allow for the safety distances of the walkways to stay within parameters. In the event of the exhibitor's stand being higher than 2.4m in height, the exhibitor is required to cover the exceeding portion of its stand walls/panels that are visible, ensuring that it looks neat and painted in white/neutral colour. Exhibitors are not allowed to apply any type of visual elements such as logos, writings, or flags on the exceeding area. PPE is required to be worn during build and breakdown by contractors and the exhibitor.
