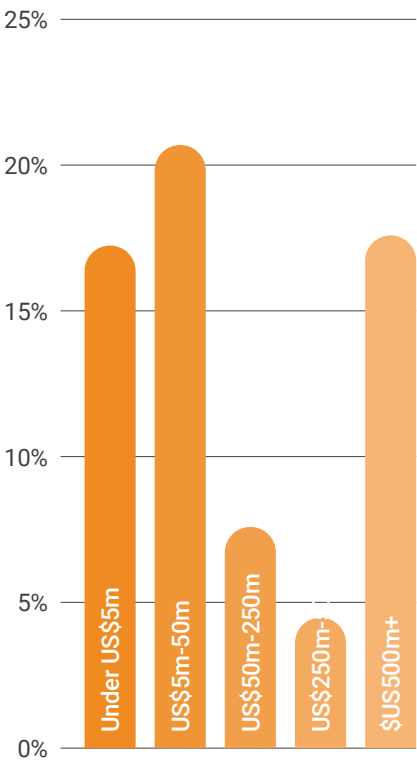

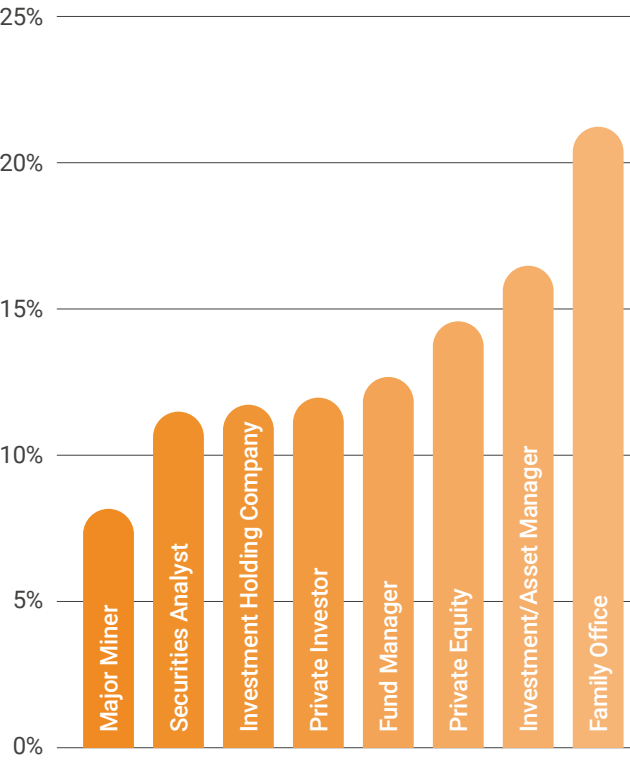
Investment Approach
